EQUITY WAITING LIST – ASSOCIATE MEMBERSHIP

- **Initiation Fee \$16,000 (non-refundable) with Equity Membership Application**
- **In the event the Equity Membership votes to reduce the Club's Equity Membership Cap from 355, those in the "Equity Waiting List – Associate Membership" category will have the opportunity to rescind their Equity Waiting List Agreements within 15 days of the Membership vote and be entitled to a full refund of their Initiation Fees. The Club will notify the affected Members by email and/or telephone call within 72 hours of the Membership vote to allow sufficient time for decision making.**

- **SOCIAL ACTIVITIES & DINING WITH SUMMER GOLF ACCESS**

- Associate Membership (Recallable)
- Year-Round, Dining Access and Social Activities/Events
- Use of golf course and golf practice facilities during the six-month period commencing May 1st and ending on October 31st ("Off-Season").
- Privileges do not allow for use of the golf course or golf practice facilities except during Off-Season.
- During Off-Season, Member will have a 7-day advance sign-up privilege to reserve golf starting times.
- During Off-Season, Member shall not be required to pay a green fee when golfing, but will pay the posted member cart fee rate for use of the golf facilities.
- Member will be responsible for personal charges incurred at the Club and all other fees and charges established by the Club, as well as guest fees for any guests sponsored by the Member.
- Member is not entitled to private golf cart privileges.
- Member is not permitted to participate in Men's or Women's Golf Association play unless otherwise determined by the Club.
- Member shall have the opportunity to use the locker and golf bag storage facilities on a space available basis upon payment of the applicable fees only after priority is given to Equity Members of the Club.
- Member will not be entitled to participate in the Club's reciprocal programs during the Off-Season.
- Member acknowledgement - the Off-Season is the primary season when the Club conducts routine agronomic and cultural practices for the golf course and practice areas. Such maintenance will require the closure of the golf facilities for portions of the Off-Season. The Club will determine the summer closing maintenance schedule at its sole discretion.
- \$2,500 Initiation Fee plus sales tax (Can be applied to an Equity upgrade)
- Social Members who joined December 21, 2015 or later (post acquisition) and paid the \$1,000 Initiation Fee may upgrade to a Social & Summer Golf Membership for \$1,500 Initiation Fee plus sales tax.

Starting Time Policy & Procedures
(Effective October 1, 2021)

- The Club employs the ForeTees Tee Time reservation system to manage starting times for golf. Starting times may be reserved via the ForeTees Mobile APP, on the Quarry website at www.QuarryGolfNaples.com, by calling the Golf Shop Staff during normal hours of operation at (239) 304-0711, or in person in the Golf Shop after 7:00 a.m.
- All players, including private cart owners, must have a starting time reserved through the Golf Shop Staff.
- Starting times are available at 8-minute intervals beginning at 7:30 a.m. with the following exceptions:
 - Club-sponsored event days (i.e. Member event shotguns)
 - Thursdays where starting times will begin at 8:34 a.m. to allow for necessary golf course cultural practices (identified on the Member Club Calendar)
- The ForeTees system will open future tee sheets to Member viewing twenty-one (21) days in advance.
- Starting times may be reserved fourteen (14) days in advance for Equity Members and ten (10) days in advance for Associate Members (Annual Golf and Club) beginning at 6:30 a.m.
- The first day the booking window opens, starting time reservations must only be booked online to prevent conflict in the golf shop. After the 24-hour period Members can book tee times with the Golf Shop Staff.
- Each Primary Member and his/her spouse are permitted to book one starting reservation per day (maximum of 2 tee times per membership).
- In addition to their own reservations, Members are permitted to add three "X players" in the other available spots to hold their foursome if they are booking 13 or 14 days in advance. Members will be required to identify the names of all "X players" 12 days in advance of their tee time. The ForeTees system will automatically remove all "X players" twelve (12) days prior to the day of play. Members booking a tee time within the 12-day booking window will not have the option of adding "X players."
- Members should not use "Ghost Names" (Member or Guest names) to reserve tee times, knowing that these players will not be playing. Those Members who habitually reserve tee times for Members and Guests who cancel last minute will be addressed accordingly by Club Management.
- To maximize the use of the golf course for the benefit of all Members, the Club reserves the right to pair singles, twosomes and threesomes with other golfers, especially during in-season months. The Golf Shop Staff will have sole discretion in pairing Members together.
- Men's Day (Wednesday's) & Ladies Day (Tuesday's) will offer alternating 8:30am & 1:00pm shotgun events for Members desiring to participate in competitive golf events. The alternating schedule will be determined annually by the Club's Golf Committee.
- All golfers must check in with the Starter or with the Golf Shop Staff in absence of a Starter prior to beginning play. Members and their guests must check in at least ten (10) minutes

prior to their starting times. Failure to check in and register at least ten (10) minutes prior to a reserved starting time may result in re-assignment, cancellation of the starting time and/or a no-show fee being charged to the Member's or designee's club account.

- Players late for a starting time may lose their right to their starting time and shall begin play only at the discretion of the Starter. The Starter will make every effort to accommodate the late players, but not at the detriment of other Members.
- Each starting time (or foursome) is limited to two (2) golf carts per foursome, regardless of cart ownership. Members with private carts may be required to share their carts with other golfers designated by the Club.
- Pace of Play: In an effort to improve Member satisfaction and enjoyment, the Club will be monitoring the pace of all 9 and 18-hole rounds of golf played. The Club's golf course Player Assistants are instructed to make sure all groups are adhering to a 3-hour and 58-minute pace of play for 18 holes. In addition, the first players to tee off in the morning are restricted from playing faster than 1-hour and 30-minutes for 9 holes and 3-hours for 18 holes in order to give the Maintenance Staff time to prepare the golf course.
- Please notify the Golf Shop Staff of any changes to a starting time at least twenty-four (24) hours in advance of the reservation.
- As per the Club's Rules and Regulations, Members with reserved starting times should notify the Golf Shop Staff of any cancellation as soon as possible. Members and/or their guests who do not cancel their starting time(s) 24-hours prior will be charged a no-show fee equal to the Member cart fee per player. Members are responsible for any time their names are used to reserve tee times by other Members.
- Guest Play: An individual may not use the golf facilities as a guest more than ten (10) times during any membership year, excluding the participation in Club tournaments and other Club-sponsored events (unless otherwise permitted by the Club). The Club may also limit the number of times any other guest may use the Club Facilities, in its sole discretion.
- Starting time reservations for Member-sponsored, unaccompanied guest play will be allowed on a space available basis at the sole discretion of the Professional Golf Staff. Members with unaccompanied guest requests should contact the Head Golf Professional.
- The Club reserves the right to restrict guest play to specific days and/or starting times in an effort to maximize the enjoyment of the golf course for its Members.
- The Golf Committee will periodically review the Club's Starting Time Policy & Procedures in an effort to maximize the enjoyment of the golf course and to ensure the process for securing tee times is equitable for all Members.

2022 Private Cart Trail Plan

Family Trail Plan \$2390 plus Tax

1. Private cart trail privileges are offered only to full golf equity members of The Quarry Golf Club.
2. Privately owned golf carts will be electrically operated, Club Car (White, or Beige), Ez-Go (Champagne or Ivory), Icon (White only) and equipped with sand bucket and a factory installed roof. Cart roof must be Beige, White, Champagne or Ivory. Golf cart size shall match club golf fleet carts, with acceptable golf bag securing area and mechanism. Seat covers and weather protection flaps do not have to match cart. Golf cart wheels can be no larger than 12". Golf carts with suspension lifts are not permitted. No other style, make or color of golf cart is permitted. Any golf cart that violates any of the above conditions will be denied the private trail plan option at The Quarry Golf Club.
3. Carts with the permanent four seats are not permitted. The Club permits the 2-in-1 Combo seat manufactured by JH Global to be installed on private carts. This combo seat folds up when not in use so golf bags can be placed on the back and the cart can be used on the golf course. Private carts with the combo seat adapter will not be permitted on the golf course with the seat adapter down and additional passengers on the vehicle.
4. Privately owned golf carts are not to be decorated with the exception that owners may have their names on the cart. No other form of decoration is permitted except Thanksgiving thru New Year's Day. During this time Holiday decorations are allowed on private carts.
5. Privately owned golf carts will not have access to the golf course until they are inspected by the golf professional, and all paper work and insurance information is submitted and payment is received.
6. The private trail fee shall not be prorated except for the first year a member applies for private golf cart privileges.
7. The private trail fee includes only the member, and/or spouse and the member's dependent children aged twenty-three or younger living at home or attending school full time, with a valid driver's license and who are named on the trail fee agreement. These persons may ride for free when riding with a member in a private golf cart that is registered and approved by The Quarry Golf Club. All guests and members who are not registered as part of the trail fee program, will pay the current cart rate when they ride in such private cart. A full golf member may elect to purchase a Single trail fee in which instance that individual is only allowed to play with no cart fee.
8. Members with registered private carts may ride in each other's cart without having to pay cart fees, but may not loan their cart to other members or guests.
9. The cart owner shall maintain liability insurance coverage on the cart for anywhere within The Quarry. Such coverage will be supplied by the insurance company and the policy number will be noted on the private golf cart registration sheet. The cart owner further agrees that he or she will not permit the use or operation of the cart by any person(s) or in any manner which would invalidate the insurance coverage or violate Florida laws.
10. The private cart trail plan is not transferable by the cart owner. And is only valid while maintaining membership in good standing at The Quarry Golf Club.
11. Limit of Liability a minimum of \$500,000 per occurrence.
12. Request Certificate of insurance naming The Quarry Golf Club as additionally insured.
13. The right to use the cart on club property is solely at the discretion of The Quarry Golf Club management and such right may be terminated at any time without notice.

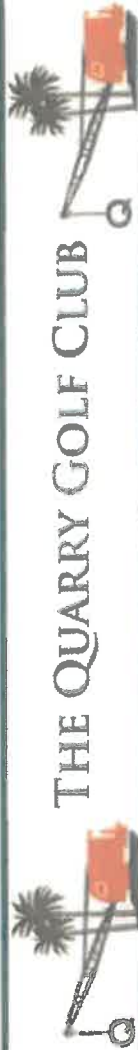

2021-2022 Food & Beverage Minimum Guidelines January 1, 2022 through June 30, 2022

Purchases which are eligible to be applied against the food and beverage minimum:

- For tracking purposes, only purchases paid via Member account may be applied against the food and beverage minimum.
- All food and beverages purchased and served on Club property (i.e. dining room, grille room, locker room, etc.).
- All individual food and beverage orders purchased "to go".
- All food and beverages purchased 'on-course' from the Halfway House and the Beverage Cart.
- All food and beverages purchased for a Member-sponsored and Member-paid banquet event at the Club. These events must be approved by the Food and Beverage Director and/or General Manager (i.e. a wedding, private dinner, luncheon, etc.). Again, only purchases paid via Member account may be applied against the food and beverage minimum.

Purchases which are not eligible to be applied against the food and beverage minimum:

- All non-food and non-beverage purchases.
- Service charges for labor, valet services, entertainment, banquet/equipment rental fees, linens, floral arrangements, decorations, etc.
- All gratuities and taxes.
- Bulk purchases of food and/or beverages product (i.e. a case of steaks, wine, etc.).

Guidelines for Member Events:

- Oftentimes, Member Social and Dining Events at the Club are 'bundled' into a per person price, which may include food, beverage, and/or a variety of service charges listed above. Only the food and beverage portion of a Member Event will be applied toward the food and beverage minimum.
- The Club's promotional materials (i.e. event fliers and email blasts) will identify the amount that is eligible to be applied against the food and beverage minimum for a Member Social, Dining or Golf Events.
- Certain "at cost" Club events 'bundled' with food and/or beverages included in the event fee are not eligible to be applied against the food and beverage minimum (i.e. Men's Crane Invitational). The Club note which bundled events may not be applied against the food and beverage minimum on the promotional materials.

Other Important Information:

- All food and beverage purchases will be applied against the food and beverage minimum at the net price paid, not the gross price when a discount is provided (i.e. alcoholic beverages purchased during Happy Hour will be accounted for at the discounted price).
- A properly charged Member food and beverage ticket will have the 'F&B Minimum Balance' at the bottom of the ticket. If this does not appear on your Member ticket, kindly notify your Server or the Food and Beverage Manager on duty.
- A Member's food and beverage minimum balance will appear at the bottom of his/her monthly club account statement.

The Club stopped selling 'Single' Memberships at the time of the developer turnover and club acquisition by the Equity Members. Existing Single Equity and Associate-Annual Golf Members were allowed to continue their Single Memberships. The Annual Food & Beverage Minimums for the Single Equity and Associate-Annual Golf Members is \$1,000.

SeaDwarf Paspalum: Tournament Conditions Every Day

The golf course at The Quarry Golf Club was designed utilizing a special variety of turfgrass called SeaDwarf Seashore Paspalum. Its rich green color provides the appearance of a bluegrass or ryegrass, which may be highlighted quite nicely with specific mowing patterns. Paspalum is not only aesthetically pleasing to the eye, but also provides an excellent year-round playing surface. Its upright nature allows for the ball to sit up in the fairway, almost as if on a tee, making for easier mid-iron and fairway wood shots. The grass also delivers a tight knit and virtually no grain, making for healthy greens that are as fast or faster than ultradwarf Bermudagrass greens.

Since it may be mowed from below 1/8 inch to over four inches, Paspalum has been utilized here at The Quarry from tee-to-green. By using just one variety of turfgrass on the entire golf course, any of these areas may be reshaped by mowing a different height and have no contamination issues from other turfgrasses, since the Paspalum is all the same cultivar.

More than that, the SeaDwarf Seashore Paspalum, is a highly environmentally friendly turfgrass. Paspalum requires less nitrogen fertilizer than Bermudagrass and is more drought tolerant, maintaining its color longer during unusual dry periods and utilizing less water. Paspalum can also utilize a wide variety of water sources, such as: potable, brackish, effluent and even saltwater. You may feel great not only about playing a better game of golf, but by also helping the environment as a Member at The Quarry.

Additionally, Paspalum is also more cold tolerant than Bermudagrass, which has afforded The Quarry the opportunity to maintain quality playing conditions and good color without overseeding in the winter. The SeaDwarf Paspalum holds its green color during the cold winter months, unlike other turfgrasses in the area, which eliminates the need to overseed with ryegrass during these months. No overseeding means quality playing conditions at times during the fall and spring when many Bermudagrass golf courses are transitioning to and from the overseeded grass.

Gentlemen's Attire

Acceptable Attire for Gentlemen: Shirts with collars and sleeves, golf shirts, slacks and golf shorts up to three inches above the knee are considered appropriate attire. Not Acceptable Attire: Untucked shirts except as described above, tank tops, printed tee shirts, fishnet tops, cut-offs, jams, cargo shorts, sweat pants, swimming attire, beach and bath style flip-flops are not permissible inside the clubhouse facilities at any time. Hats/caps may only be worn inside the Golf Shop, Member Lounge, Locker Rooms, Fitness Room, and Golf Course Maintenance Facilities. Hats/caps must be removed in all other clubhouse facilities.

Ladies' Attire

Acceptable Attire for Ladies': Dresses, skirts, slacks, golf shorts, dress shorts, Capri pants, golf shirts, golf tee shirts and golf blouses are considered appropriate attire. While denim is acceptable; we ask that denim be hole free, non-frayed and not cut-off. Hats/caps may be worn in the clubhouse facilities after golf, including the Main Dining Room after a golf event, but not for a non-golf related event or regular dining hours.

Not Acceptable Attire: Halter tops, tank tops, fishnet tops, cut-offs, sweat pants, swimming attire, short shorts, beach and bath style flip-flops are not permissible in the inside dining areas.

Fitness Room Attire

Members utilizing the Fitness Room are expected to abide by the clubhouse dress code policy prior to and after working out, with the exception that Members may enter and exit the clubhouse for a fitness session via the Member Lounge. Members in fitness attire should not navigate any other areas of the clubhouse.

Cell Phone & Mobile Device Policy

If you are sitting at a table or lounge and receive a call on your cell phone or mobile device, kindly excuse yourself and go to the outdoor Terrace, Patio or an area outside the clubhouse that will not disturb others. If you are talking to the person on a cell phone or mobile device as you are moving to the appropriate area, please use your indoor voice. Electronic devices should not be a distraction for Members and guests enjoying the Club.
